 - a. Finances

i. Project Funding Decision

- Deposited kickoff money, balance will be \$723
- Now we need to determine how to spend the money
- Proposal 1: Use money for Tournament Volunteer Reimbursement
 - a. Should be restricted to Carleton students (because all funding came from Carleton)
 - b. Should we open the reimbursement to mentors or only event volunteers
 - c. Recommendation to make tailored reimbursement
 - d. Recommendation to follow up with respective teams to double-check that mentor reimbursement makes sense in this situation
 - e. Mentors should be able to apply, but will have a separate approval step of approving it with the FRC team
 - f. How much money will we place towards this initiative
 - g. Recommendation to use only \$500 to leave \$225 for the coming year

- h. Recommendation creating per person cap so that if we have only a few applicants they do not take large pieces of the fund
- i. Recommendation to reimburse the money only after reviewing expense receipts to qualify reimbursement
- J. If using advance applications, the deadline should be set to Feb. 27, after opening this Wednesday (Jan. 30) for a full month
- Recommendation to set a percentage cap so that it is based on need of actual expenses "up to 50% off" of expenses, ensures that no one is paid to do it, and still keep their expenses overall low
- I. Make decision at a meeting after reviewing expenses
- m. At this point in time eligibility will be for Ontario FRC District Events only
- n. Reimbursement can be done through a member of the executive
- The application should say that to get money their receipts will be reviewed by the members of the executive
- Motion to Approve the format of grants discussed and to proceed with the application process: All present executives in favour, motion passed
- Proposal 2: Keep money as contingency fund for upcoming year
 - Decision was made to not keep the money and use the money for the volunteer travel reimbursement
